The City Center is designed to seamlessly integrate retail, residential, medical and recreational spaces to foster a harmonious live-work-play environment. Everything that one would need is designed within the master plan of the development with multiple office, retail and residential buildings providing work opportunities, housing, shopping, and recreation areas all located within walking distance.

The plans include construction of the much-anticipated road and bridge connecting Blackhawk Blvd and Bay Area Blvd, along with multiple traffic controls, drainage improvements, and the addition of a new fire station on the property.
